

Guidelines for State level Symposium to be held on 28th of January 2025, on the UN theme of World Wetlands Day 2024 at Directorate of Environment and Climate Change Complex

Key Features

- 1) One Moderator
- 2) Three Jury
- 3) One slide of ppt or poster
- 4) 6 minutes presentation duration
 - A) Content-40 marks
 - relevance to the topic
 - clear introduction, body and conclusion
 - depth of coverage
 - accuracy of Information
 - B) Presentation- 40 marks
 - clarity of speech
 - confidence and body Language
 - engagement with audience.
 - C) Timing -10 marks
 - adherence to allotted time
 - effective time management
- 5) Two minutes for interaction or comments after each presentation -10 marks
