# THE COURT OF THE DISTRICT MAGISTRATE, THOUBAL DISTRICT.

### CRIL. MISC CASE NO. 2 OF 2025

#### ORDERS UNDER SECTION 163 OF BNSS, 2023 Thoubal, the 7th April, 2025

No. 4/65/DC(TBL)/2009/L & O/ 2024: Whereas, Superintendent of Police, Thoubal vide letter No. 9/1(P)/2025/SP-TBL dated 7th April, 2025 have reported that on 06/04/2025 after about 06:30 PM approximately about 7000/8000 strong mob armed with lathis and stones stormed into the house of one Md. Asker Ali S/o Haji Nawab Ali of Lilong Sambrukhong Mamei and set it ablaze. Further, it is reported that the matter is very sensitive in and around Lilong Assembly Constituency and there is likelihood of further disturbance which poses a risk to peace and public tranquility in the Lilong Assembly Constituency and has requested the undersigned to issue prohibitory orders under Section 163 of BNSS, 2023 to the whole area of Lilong Assembly Constituency

Whereas, I have perused the report submitted by the Superintendent of Police, Thoubal and is of the opinion that there is sufficient ground for proceeding under section 163 of BNSS, 2023 to prevent serious breach of peace, disturbance of public tranquility and imminent danger to human life and properties

Whereas , there is emergency and circumstances do not permit serving of due notice upon the public, this order is passed ex-parte under sub -section 2 of Section 163 of BNSS, 2023 and is directed to the public in general.

Now, therefore, I, Shri A. Subhash Singh, IAS, District Magistrate, Thoubal in exercise of powers vested upon me under sub - section 1 of Section 163 of BNSS, 2023 do hereby prohibit, with immediate effect and until further orders:

Assembly of 5 (five) or more persons

2. Carrying of firearms, swords, sticks , stone or other lethal weapons, sharp edge articles/objects of any description which can be used as offensive weapons.

This order shall not apply to agencies of the Government involved in the enforcement of law & order, and maintenance of essential services .
